7. New Business

-Barbers who have gone past 5 years of nonrenewal.

Ashley reached out to the state for clarification on what they need to do to renew after 5 years. The board has no clear language and as such the only legal thing the board can do is require retesting for barbers who have gone past 5 years of non-renewal of a Barber License.

- -Board needs to have SSN as a requirement on our license applications.
- -Child support needs a contact from the board incoming Sec./Treasurer Amanda Guzman will fill out the contact form.
- -Need to update our license and exam applications for next year to meet the requirement for SSNs.
- -Information gathering by the State of ND on the boards and commissions will be contacting our board throughout the next year.
- -Barbershops with other businesses in them need only have a partition to the ceiling height in that business.
- -Chain salons need to have a barber on premises to be listed or licensed as a barbershop.
- -Tona Stevenson should have reimbursement for coming to boards and helping with the testing.

- -Motion needs to be made to allow Amanda Guzman access to the Bank account when her term starts in January. Ashley Johnson makes a motion for Amanda Guzman to take over the Gate City Bank account beginning on January 1st, 2024. Lance Ekern Second. All voting Sandra (y), Lance (y), and Ashley (y).
- -Practical exam guidelines for our ND test follows the Minnesota practical testing. Further research denoted some similarities between other states with some differences one being that the students could use mannequin heads. Not all boards have the same practical testing but the ND Board of Barber examiners at this time does not feel like the practical exam needs to be changed.
- Jim McGuire from SD State Board of Barbering contacted the board and would like to watch our state practical exam. Our exams are closed to the public, however. Lance makes a motion to table allowing Jim McGuire to attend our test until January. Sandra seconds the motion. All voting Lance(y), Sandra (y), and Ashley (y).

- The Board needs to have the High School Diplona or GED by the exam application deadline for testing and licensing.
- Sec./Treasurer has the authority to license reciprocity applications as long as they meet the
 requirements without the full board meeting. This has already been approved by the board
 in the prior terms.
- A Student reached out the board to complain about a former instructor's comments about them. As the instructor no longer holds a current license this is a civil matter between the two.
